#### 1 Introduction

This document provides an updated report and analysis of the results from the 2013 Huish Champflower Parish Survey.

The first report was initially presented to and then reviewed by the Huish Champflower Parish Council meeting of 9<sup>th</sup> July 2013.

Following the Parish Council meeting, a copy of this report was posted to the Parish website (www.huishchampflower.org) and made available for download.

This latest version of the Parish Survey results aims to provide further granularity of the results, comparing responses according to:

- Households with children vs. those households with No Children
- The number of years that the household has resided in the Parish

In addition this report now incorporates a number of charts.

# 2 Background to Survey

#### 2.1 Initiation of The Survey

Huish Champflower Parish Council discussed and agreed (11 June 2013) that the timing for an update to the 2010 Parish Plan was appropriate. The previous and more detailed Parish Plan Survey had been conducted in May 2010. The next more detailed survey is not due till 2015. A shorter, interim survey was agreed to be "best practice".

The Parish Council discussed the content of the survey questionnaire and agreed a set of questions to enable:

- A quick update to the existing Parish Plan Survey
- Inclusion of views of residents new to the Parish since 2010
- Assessment of the views of residents toward a number of locally controversial (current and prospective) issues – enabling the Parish Council to better understand and represent the views of residents

#### 2.2 Survey Process

- Survey questionnaires were printed, back-to-back on a coloured paper.
- The surveys also included physical handwriting on both sides, detailing where to deliver responses and also reminding respondents that the survey continued onto the back page.
- Surveys were hand delivered to all households in the Parish by a number of volunteers. Deliveries commenced on Friday 21<sup>st</sup> June 2013.
- Residents were also provided with an option to request an electronic version of the survey.
- Residents were presented with 3 options for the returning of surveys:
  - 1. By email to ParishSurvey2013@HuishChampflower.org
  - 2. At a "Survey Drop Box" located outside The Castle, The Field House and Watercombe House
  - 3. By hand to a named "volunteer"
- Following a similar approach as adopted for the 2010 Parish Survey, all households were revisited by
  volunteers to collect completed surveys. For the purpose of this update, empty properties (For Sale,
  occupants absent, etc.) were not visited more than once.
- All survey responses are treated anonymously.

#### 2.3 Data Processing & Interim Reporting

As per the 2010 Parish Plan Survey, all survey data was processed by Stephen Kimsey, a member of the Huish Champflower Parish Council and who has many decades experience of working as a market analyst. Analysis was undertaken using a market research application called Snap (quantitative responses) and also MS Excel (qualitative responses).

All survey data is available for inspection (subject to advance request).

#### 2.4 Survey Funding

To date there have been  $\underline{NO}$  costs charged to the Parish Council for any aspect of the current survey.

- Paper & Printing were donated by a Parish Councillor
- <u>Volunteers</u> hand delivered surveys to residents
- Data processing was undertaken for <u>free</u>

#### **3** Summary of Top Line Results

Results have yet to be examined by segment (see 8.2 Segmentation of Analysis). A variation in the priorities is expected to be observed when responses are segmented.

The 5 most important issues to households in Huish Champflower are:

Preservation of the local and surrounding landscape (4.81) Preservation of the local environment & wildlife (4.72) Access to GP Health services (4.63) The security of your household, property & land (4.61) The cost of heating fuel (4.51)

It is also important to ADD <u>Rising Household Bills</u> to this list as this is the most important issue facing families in our Parish that have children.

The <u>5 least important</u> issues to households in Huish Champflower are:

Part-Time Employment in or within 15 miles of our Parish (3.02) Availability & accessibility to local (within 10 miles) leisure amenities (3) Full-Time Employment in or within 15 miles of our Parish (2.84) Access to good or outstanding education services (2.83) Availability of affordable housing in our Parish (2.72)

20 Households commented on issues which are of current concern to themselves. Of these 20:

30% relate to concerns with possible development of Wind Turbines 25% relate to concerns with possible development of "Solar Farms" 20% relate to the desire to have much faster Broadband 15% relate to concerns with Traffic driving the Parish (mainly speed) 15% relate to concerns with any development of Open Fields

In descending order of Support for 6 prompted possible issues to face the Parish:

Housing development on existing developed land (2.5) Widening of Washbattle Bridge (2.41)
Development of small scale industrial units (2)
The development of a commercial size solar farm (i.e. several acres) (1.51)
Erection of 50m+ high Wind Turbines (1.28)
Housing development on open fields (1.26)

The profile of the average survey respondent was:

A household of 2.2 adults and 0.4 children (under 18 years) Resident for 12.6 years at current property in Huish Champflower

- an average of 2.2 adult residents per household
- An average of 0.4 children (under 18) per household
- A total of 134 residents (115 adults and 19 children) covered by the survey (excluding 5 No Replies)
- An average occupancy of 12.6 years

# **Segmentation of Analysis**

To provide additional granularity to the results it was suggested that the data could be further explored using the following segments:

- Households with children vs. those without children (under 18 years)
- Number of years living at current property

A further possible segmentation was also considered.

• Number of residents (adults & children) in a household

Due to the number of No Responses, particularly relating to the Number of Children in a household, it was decided to NOT review this area.


# 5 How important for your household are the following?


A number of interesting differences can be observed in the priorities of households (importance of issues) dependent on whether they have children, or how long they have resided in the Parish.

The above Ranking of the Mean Score of Importance aids in the identification of the differences existing in priorities between households.

Understandably <u>households with children</u> attach more importance to a number of practical day-to-day issues – for instance Rising Household Bills is the most important issue for this group vs. Preservation of the local and surrounding landscape for those households <u>without children residing at home</u>.



The higher the Mean Score the more important the issue.

### 6 Listing of other local issues of concern to households

#### **6.1** Headline Review

34.5% of those responding to the survey commented on a Local Issue of concern to their household. The responses are:

#### Comment

Big no to wind farms and solar panel farms (though not small solar installations e.g. As Jews Farm, or on roofs).

Biased parish councillors composing surveys with slanted questions using public money to promote their views.

Development on open fields should not be allowed. No solar farm and wind turbine to fill up people pockets.

Clearance and salting of roads in winter months. They should be cleared from Huish Champflower up to Sperry X as they used to be.

Dog owners allowing their pets to foul on private land and not taking responsibility for removing these "accidents" of nature.

1; Better Broadband speed would be useful. 2; Concerned to have fields of solar panels - use on property is fine 3; Concerned about wind turbines in inappropriate places especially if not supported by the community 4; Widening of Washbattle Bridge may encourage more traffic using Huish Champflower as a rat run 5; Development of small scale industrial units - depends if on an already developed site and for a resident and not impacting directly on others

Government pressure on new build will result in inappropriate development of the village; Widening of Washbattle Bridge - Why? Leave it alone it protects the village!

We need full support for local rural workers to work and live on the land as this landscape will not stay looking as nice as it is without these people

The pressure of Brendon Energy on our parish and surrounding district

1; The apparent fracturing of our community over recent years due in the main to the selfish agenda's of a few residents 2; A safe walking route from the village to the field would be useful for children and encourage use of hall, field and Church 3; Dogs off the leads wandering the roads 4; Badly driven agricultural vehicles - usually by teenagers trying to be farmers!

Need for improved Broadband speeds

Gritting the roads in winter; Faster broadband; Encouraging wildlife initiatives

Lack of reasonably priced petrol

Wind turbines

It is of paramount importance to us that the special nature of this area is preserved at all costs. Development of any kind could put these special qualities in jeopardy.

Strongly against wind turbines and Big Solar!

Possible solar and wind turbine sites - strongly against

Constant damage by large vehicles to Washbattle Bridge. Instead of widening the bridge - dig out an area of the bank to the left side of road approaching the bridge to allow lorries - wide loads to approach bridge in a straight line. We do not want a bridge similar to the one in Clatworthy. Maybe a weight/width restriction could be put in place. Speed of traffic travelling through village - we don't want street lights but we would like slower traffic.

Very bad pothole halfway up Castle Hill


We are concerned with the speed of traffic passing through the village, both light vehicles and heavy tractors included.







A scoring system of 1 to 5 was used – with 1 indicating "No support at all" and 5 indicating "Strongest Support".



The higher the Mean, the greater level of support.



The greater the Mean Score the higher the level of support.

A Mean Score of 5 would equate to Very Strong Support.

As is observed there is very little support for any of the prompted issues/topics.

More specifically it is observed that there is hardly any support for 3 issues:


- Housing development on open fields

The following chart (overleaf) compares the Mean Scores provided by each of the segments for each prompted topic/issue.



#### It is observed that:

Respondents who have lived in the Parish for the longest period of time (21+ years) are generally more in favour of the widening of Washbattle Bridge – though the Mean Score of 3.13 (from a scale of 1 to 5, where 5 would indicate the highest level of support) cannot be regarded as suggesting any real support for this particular initiative (proposed by Somerset County Council Highways).
