**Meeting of Huish Champflower Parish Council**

| 3 | <p><b>Highways Updates</b> 2 closures to the road at Langley Marsh. The second closure did not allow for emergency vehicles to come through for 24 hours a day over a 3-day period. Objections have been made and no road signs have gone up.</p> <p>A new Highways contractor is starting in April called Kier, we have to wait and see what the impact of this will be.</p> <p>Grit, due to the mild weather there has not been a great demand for grit, so reserves are good in the bins. In Wiveliscombe the Co-op delivery and the bus managed to cause gridlock and traffic jams of 25 minutes, could this be coordinated? Would cameras monitoring the parking in the square be a better option than traffic wardens?</p> <p>The bus service cut means youngsters coming back from college have a very long wait to get home.</p>  |                     |
| 4 | <p><b>Updates from Somerset Council Councillors. - Report from SK re LCN summed things up well.</b></p> <p><b>Highways</b> - reported the rapidly deteriorating condition of Scotts Hill - the flooding (blocked drain), large pothole (with a new one developing opposite) and the road edge collapsing a bit further along the road toward Clatworthy. Online forms completed.</p> <p><b>Police</b> - discussed the suspected night-time drug dealing directly to the PCSO. Also mentioned the possibility of the Police coming to the village. They are doing a Pop up Police Station visits around the area - when they visit they can security mark bikes and other items, as well as provide info on initiatives such as Farm Watch - and also other general policing issues. This is unlikely to happen until May (at earliest). This is something about which we will need to liaise with the Village Hall.</p> <p><b>Recycling Centres</b> - all still up in the air - no decisions. It was widely agreed that the current proposals to close Williton and Dulverton are unfair to our area - given size, increasing number of houses (Williton/Watchet/Minehead), distance to alternatives - and also the likelihood of increased fly-tipping. The consensus was it would be fairer to make cuts to opening hours across all Somerset recycling sites. The County Council are in discussion with the operators (Biffa) and further consultation will happen over the next few months. Various ideas were floated - including a complete re-hash of the recycling system - following the approach that many EU countries have. The County Council will be asking why people use recycling centres</p> <p><b>Civil Contingency/Emergency Planning</b> - some interesting information - in the first instance we need to encourage the Village Hall to register as a Place of Safety - aside from the sticker and a few leaflets - this will open some grant funding opportunities for the Hall - for instance improving disabled access. The Community Place of Safety Scheme aims to provide a safe place (refuge if you like) as well as a Hub for emergency services and others. A good idea and something we should encourage the Hall to participate in.</p> | <p>SK</p> <p>SK</p> |
